## TERMS AND CONDITIONS FOR THE ART CONTEST

#### § 1

## **General provisions**

1. The contest titled: "Dream trailer" is organised by Maszoński Logistic Sp. z o.o. Sp. k.

#### § 2

## **Competition Objectives**

The competition involves the following objectives:

- 1. Representing a truck trailer through the eyes of a child.
- 2. Developing artistic skills of children and youth.
- 3. The main goal of the competition is to select the works which most accurately depict the objectives.

#### § 3

### **Organisational assumptions**

- 1. The competition shall be held in the following age categories:
  - 1) 5-6 years
  - 2) 7-12 years
  - 3) 13-16 years
- 2. Works submitted to the Competition shall be originals, unpublished anywhere else. Each participant shall only prepare one work.
- 3. The works shall be made using any technique (e.g. painting, drawing, graphics, collage, etc.) in A4 or A3 paper format.
- 4. Each work shall be described on the reverse side in accordance with the following formula:
  - Full name
  - Age
  - Phone
  - Full name of the Parent or Legal guardian
- 5. Entering the Competition shall automatically grant royalty-free economic copyrights to use the works for promotional and marketing purposes of the organiser of the competition, including:

Within the scope of recording and copying the artistic works using any and all technical means, including printing, digital, magnetic recording, saving in computer memory, saving in the permanent computer storage (uploading, downloading), within the scope of distribution - exhibition, reconstruction, making works available to the public, reproduction, recording, use on the Internet, television, press advertisement, on posters, leaflets, tarpaulins, semi-trailers, within the scope of reproduction and use in advertising, within the scope of reproduction and use in publications published by Maszoński Logistic Sp. z o.o. Sp. k. and Maszoński Logistic GMbH.

- 6. The works shall be submitted with a participation card (attachment no. 1) to be signed by the Parent or a person legally authorised to represent the child.
- 7. Works submitted to the Competition shall not be returned to the Authors.
- 8. Works that do not meet the participation rules shall not be subject to evaluation.
- 9. Situations not covered by these regulations shall be settled by the Competition Organiser.

- 2. Works submitted after the deadline shall not be subject to evaluation.
- 3. The Winners of the Competition shall be selected by the Competition Commission appointed by the Organiser.
- 4. The Commission shall take the following into account in the evaluation process:
  - Adequate selection of a theme
  - Quality of the workmanship
  - Originality
- 5. The decisions of the Competition Commission are final.

## Announcing results of the competition

- 2. Laureates shall be notified by phone by 10 June 2019.
- 3. The works of the Laureates shall be displayed at a post-competition exhibition at the Organiser's premises. The exhibition shall be open during the awarding of prizes. The place of the exhibition shall be provided after the announcement of the results of the Competition, on the following website <a href="www.maszonski.com">www.maszonski.com</a>, <a href="www.maszonski.com">www.facebook.com</a>/MaszonskiLogistic/and on the bulletin boards at the company's headquarters.

#### § 6

# **Competition prizes**
